AN ORDINANCE TO CREATE THE POSITION OF CHIEF TRANSPARENCY OFFICER WITHIN THE OFFICE OF THE MAYOR AND FOR OTHER PURPOSES

WHEREAS, the City of Atlanta (the "City"), a municipal corporation within the State of Georgia, is subject to the requirements of the Georgia Open Records Act (O.C.G.A. §50-18-70, et seq.) (the "Georgia Open Records Act"); and

WHEREAS, the City's full compliance with the requirements of the Georgia Open Records Act is a vital and essential component of creating and maintaining public trust and enhancing the City's effectiveness; and

WHEREAS, the City intends to implement a comprehensive plan for best in class policies, procedures, and protocols for transparency and compliance with the Georgia Open Records Act; and

WHEREAS, the Mayor has determined that it is in best interests of the citizens of the City of Atlanta and its visitors that such formal protocol for transparency and compliance be established; and

WHEREAS, City Council concurs with the Mayor that such protocol is in the best interests of the citizens of the City of Atlanta and its visitors;

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA:

Section 1: That the position of Chief Transparency Officer be created within the executive branch at salary grade 30.

Section 2: That this position shall have oversight of the enforcement of citywide compliance with the requirements of the Georgia Open Records Act.

Section 3: That all ordinances in conflict herewith are waived.
