**AN ORDINANCE BY COUNCILMEMBER J. P. MATZIGKEIT TO ESTABLISH THE SALARIES FOR THE MAYOR, COUNCIL PRESIDENT AND MEMBERS OF COUNCIL FOR THE TERMS OF OFFICE BEGINNING JANUARY 2022; AND FOR OTHER PURPOSES.**

Whereas, the City of Atlanta Elected Officials Compensation Commission (the "Commission") was created pursuant to Section 2-701 of the City Charter; and

Whereas, the Commission was most recently populated in 2020 in accordance with Section 2-702 of the City Charter; and

Whereas, the Commission spent numerous hours reviewing past and current surveys of the salaries of elected officials in other United States cities learning the roles and responsibilities of City of Atlanta, interviewing City of Atlanta elected officials, discussing, debating and deliberating the issue of salaries for elected officials of the City of Atlanta; and

Whereas, as required by Section 2-703 of the City Charter, an advertised public hearing was held on Thursday, October 22, 2020 at 3:00 p. m. remotely due to the closure of City Hall to the public because the coronavirus pandemic; and

Whereas, the Commission completed its work and the City Council of Atlanta accepted its report and recommendations on November 2, 2020; and

Whereas, any future action by the City Council regarding the compensation of elected officials is not restricted or precluded by these recommendations, and it is the intention of the City Council to take into consideration the recommendations made by the Commission and to otherwise comply with the requirements for such legislative action as established in Section 2-306 of the Charter; and

Whereas, any action by the City Council resulting in a salary change shall not become effective until the date of commencement of the terms of office of the officials elected at the next regular municipal election following the date of any such action.

Whereas, the Atlanta City Council, has taken into consideration the report and recommendations of the Commission regarding the salaries which it deems appropriate for the Mayor, Council President, and City Council members who will take office in January 2022.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

**SECTION 1:** That the recommendations of 2020 City of Atlanta Elected Officials Compensation Commission hereby adopted for the Mayor, the Council President, and the Members of Council of the City of Atlanta, Georgia for the terms of office beginning January 2022.

**SECTION 2:** That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.


