A RESOLUTION BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE AUTHORIZING THE MAYOR OR HER DESIGNEE, TO ACCEPT ON BEHALF OF THE ATLANTA POLICE DEPARTMENT, THE DONATION FROM THE ATLANTA POLICE FOUNDATION OF FOUR LIGHTWEIGHT MOBILE SURVEILLANCE TRAILERS VALUED AT ONE HUNDRED FORTY-FOUR THOUSAND TWO HUNDRED FIFTY DOLLARS AND ZERO CENTS (\$144,250.00); AND FOR OTHER PURPOSES.

WHEREAS, due to the number of large events which take place within the city limits of Atlanta, additional surveillance technology will assist protecting our citizens; and

WHEREAS, the trailers operate from solar energy and can be deployed anywhere in the city; and

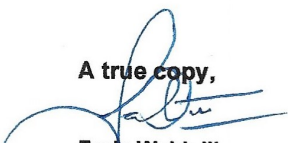
WHEREAS, the Atlanta Police Foundation purchased four (4) lightweight mobile surveillance trailers valued at One Hundred Forty-Four Thousand Dollars and Zero Cents (\$144,250.00) from Compass Security Solutions; and

WHEREAS, the Atlanta Police Foundation wishes to donate the trailers to the City of Atlanta Police Department; and

WHEREAS, the four vehicle identification numbers are 4C9CS1218LG459011, 4C9CS121XLG459012, 4C9CS1211LG459013, and 4C9CS1213LG459014.

NOW THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or her designee, on behalf of the City is authorized to accept the donation of four lightweight mobile surveillance trailers from the Atlanta Police Foundation valued at One Hundred Forty-Four Thousand Dollars and Zero Cents (\$144,250.00).

BE IT ALSO RESOLVED, that all resolutions or parts of resolutions in conflict herewith are hereby waived for purposes of this resolution only and only to the extent of the conflict.

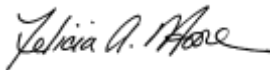
